



## **Mill Farm Eco Barn competition Terms & conditions**

### **1. How to Enter**

- 1.1. To enter the Competition, entrants will need to pay a £5 donation at <https://www.justgiving.com/crowdfunding/spendforsyria2017holiday> for every ticket purchased. E.G. £5 Donation = 1 Entry Ticket, £15 Donation = 3 Entry Tickets
- 1.2. All entrants must leave their Instagram, Twitter or Facebook name in the comments, alongside their donation on the Just Giving page, so they can be contacted in the event that they are the winner.
- 1.3. The winner will be selected at random after the closing date from all entrants.  
There will be only one winner.

### **2. When to Enter and Who can Enter**

- 2.1. The Competition will run from Monday 21st November 2017 to 11pm (GMT) Wednesday 6th December 2017.
- 2.2. The winner will be announced within 72 hours of the competition closing.
- 2.3. Entrants can enter at any point between these dates
- 2.4. Entrants can enter the competition as many times as they like, and can like, share, comment, tweet and RT the details of the competition
- 2.5. The Competition is only open to people aged 21 or over, excluding employees and agents of Mill Farm Eco Barn and anyone professionally connected with the administration of the Competition

### **3. Prize**

- 3.1. The Prize is a 3 night stay at Mill Farm Eco Barn for up to 8 people (adults or older children) and up to 2 infants (who sleep in a cot) and two dogs, excluding puppies. Extra guests are not allowed.

The winner is able to transfer this Prize to a week's stay at Mill Farm Eco Barn, and take £600 off the cost of the week in the Eco Barn, in the following months October, November, December, January, February and March, excluding school holidays, following discussion and agreement with Mill Farm Eco Barn

- 3.5. The winner must pay a damage deposit of £200 when booking which is refundable on leaving, providing there has been no damage to the property
